

Shift Share Analysis of Employment and Wages for Polk County

Published Annually by the Central Florida Development Council, October 2023

Overview

Polk County saw significant private sector employment growth from Q1 2019 through Q1 2023, adding just under 32,000 jobs (16.2% growth) during the period. This is particularly strong when compared to the national growth which saw an increase of only 4.0% during the same period. The difference in growth between the nation and county accounted for nearly 24,000 jobs locally. Wages have also improved overall, with 24.5% growth to an average weekly wage of \$1,041. This, however, just barely outpaced by the growth of wages nationally which grew by 24.2%. Overall, Polk County had strong jobs growth, with similar wage growth, relative to the nation.

While the economy has mostly stabilized, there continues to be a tight labor market and an ongoing fight to keep inflation down. It is expected that the efforts to control inflation will put pressure on the economy and it is still uncertain whether this will start impacting the labor market. Despite all of this, the local job market remains strong.

Using Shift Share Analysis, we are able to see a breakdown of what sectors and subsectors were responsible for the job growth, above and beyond what would have been expected. The growth can be broken down into 3 components:

1. The National Component – how many jobs would have been created if, at the county level, the sector grew at the overall national average (4.0% in the study period).
2. The Industry Component – the difference in job creation between the overall national average and the sector, at the national average.
3. The Local Component – the difference in job creation between the actual local employment change and what would have been expected given the overall national and industry growth.

To see how Polk County has fared, it is important to separate out the Local Component from the overall job growth. This was studied down to the 3-digit NAICS subsector level.

At the 2-digit level, we saw strong local growth from:

- Transportation and Warehousing (42.5%)
- Finance and Insurance (16.9%)
- Real Estate and Rental and Leasing (15.4%)
- Utilities (15.3%)
- Administrative and Waste Services (13.6%)
- Accommodation and Food Services (13.6%)

- Retail Trade (12.1%)

We saw moderate growth from:

- Construction (9.9%)
- Management of Companies and Enterprises (9.6%)
- Other Service, Except Public Administration (9.0%)
- Educational Services (8.5%)
- Health Care and Social Assistance (8.3%)
- Manufacturing (7.9%)

We saw zero growth or shrinking from:

- Agriculture, Forestry, Fishing and Hunting (-25.2%)
- Arts, Entertainment, and Recreation (-7.5%)
- Mining, Quarrying, and Oil and Gas Extraction (-7.3%)
- Information (-2.1%)
- Wholesale Trade (-1.9%)
- Professional and Technical Services (0%)

There can be much variation among the 3-digit subsectors within each sector. Analyzing this data may shed light on where the growth came from and how the growth in some areas compares to the losses in others. It is also worth considering the impact to the local economy of the jobs gained and lost. Two measures we can look at are Location Quotient (LQ) and average wages. LQs greater than 1 represent industries that have basic jobs for the Polk County economy, where basic jobs are ones above and beyond those necessary to meet the average demand for goods from that subsector given the population of the county. In other words, the basic jobs are the ones that produce the goods and services we “export” outside of the county, bringing outside money in. High LQ subsectors provide significant economic benefit to our county by bringing that outside money in. It is also worthwhile to study the changes to average wages in the subsectors. To do this, we can also conduct a Shift Share Analysis on the wages at the subsector level.

Industry Summaries

Agriculture

Within Agriculture, the most significant losses come from Crop Production, which lost 407 jobs in Polk County. This has a somewhat mitigated impact due to the lower than average wages (\$756 weekly). Wages for the sector as a whole were up slightly and slightly behind wage growth for the industry (local component of -2.4%).

Mining, Quarrying, and Oil and Gas Extraction



There were 650 jobs in Mining, Quarrying, and Oil and Gas Extraction. These jobs are less impactful with a LQ of .66, however they have wages of \$2,199 per week.

Utilities

Within Utilities there was meaningful growth for jobs (+18.5% overall, 15.3% more than at the national level), with wages outpacing national growth for the industry by 1.9%. Despite the relatively small size of the private Utility sector, these jobs are among our highest wage jobs with weekly wages of \$2,823. Continued growth here would create a meaningful economic impact.

Construction

The time-period under review saw a significant uptick in construction activity as building activity picked up with significant demand throughout 2021 and 2022, and the interest rate hikes we are currently experiencing only began impacting the market in 2023. Overall, construction jobs are up 17.0%, with local growth stronger than national industrial growth by 9.9%. Wages for the industry locally are up as well (+27.1%) with Polk County outperforming the national industry averages (+6.5%). Higher interest rates may continue to put pressure on the construction industry going forward and we will likely see slower growth and reduced builder confidence in the near term. This should abate once the Federal Reserve begins pulling back on interest rates.



Manufacturing

In Manufacturing, Polk County grew while jobs remained nearly flat nationally (+8.6% in the county, 0.7% nationally, for a local factor of +7.9%). There is, however, meaningful variation within the sector. The largest growth came from Nonmetallic Mineral Production Manufacturing and Food Manufacturing which added 372 and 671 jobs, respectively. Nonmetallic Mineral Production Manufacturing pays above average wages (\$1,520 weekly) with a LQ of 3.2 while Food Manufacturing pays an average wage (\$1,270 weekly) with a LQ of 2.7. Both subsectors provide Basic Jobs and have a wage above the county's average.

Wholesale Trade


Wholesale Trade employment grew by 1.4%, underperforming national growth with a local growth component of -1.9%. The additional jobs came from Merchant Wholesalers, Durable Goods, which added 486 jobs while the Nondurable Goods subsector lost 344 jobs. Wholesale Trade jobs carried an average wage of \$1,555 per week.

Retail Trade

Within the Retail Trade sector, there was significant variation among 3-digit classifications. It should also be noted that the NAICS classification system made changes to some of the classifications for 2022, so while current jobs are considered accurate the changes at the 3-digit level are only approximations. Overall, Retail Trade grew by 11.4%, adding 3,248 jobs, while jobs shrank nationally in the industry, leading to a local component of +12.1%. Among Retail Trade, the only subsector with above average wages is the Motor Vehicle and Parts Dealers (\$1,275 weekly), they experienced solid wage growth locally (+5.8%).

Transportation and Warehousing

Job growth for Transportation and Warehousing outpaced the national industrial average by a wide margin (local component of +42.5%) and was responsible for over 11,000 new jobs since 2019. Warehousing and Storage jobs outperformed national industrial growth (local component of 28.7%) and added just over 9,000 jobs overall. Warehousing and Storage continues to bolster the county's strong position in the industry with an LQ of 6.4. The next largest contribution from that industry was from Truck Transportation, which added over 1,200 jobs with a local growth component of 17.7%. These jobs are particularly important as the Truck Transportation weekly wages (\$1,269) are above the county average.



Information

The Information sector added 94 jobs, but grew at a slower pace than the national average (-2.2% local component), with much of the growth coming from the Telecommunications subsector which added 294 jobs. With a LQ of 1.1 and above average wage (\$1,168 weekly), Telecommunications is of growing importance to the county. Job losses in the industry can primarily be attributed to Publishing and Broadcasting, which lost 115 and 86 jobs, respectively.

Finance and Insurance

The net job gain in Finance and Insurance was substantial (+21.7%, for nearly 2000 jobs) with a significant local component (+16.9%). The growth was driven mainly by Insurance Carriers and Related Activities, where 1,320 new jobs were added. The gains in insurance are more impactful with a LQ of 1.7 with above average wages (\$1,340 weekly). Wage growth in the sector lagged the national trend with local component of -8.7% and overall growth of 15.1% to an average of \$1,593 per week.

Real Estate and Rental and Leasing

Real Estate and Rental and Leasing outperformed the national industrial employment growth (local component +15.4%), supported by growth at the Real Estate subsector level (local growth component +10.7%). This is of relatively low impact as the LQ is below 1 and the average weekly wages (\$859) are below the county average.

Professional and Technical Services

Professional and Technical Services is in line with the national industrial employment growth pace (local component -0.0%) but remains a low impact portion of the economy with a LQ of 0.5, however the wages (\$1,323 weekly) are above county averages.

Management of Companies and Enterprises

Management of Companies and Enterprises outpaced the national industrial employment growth (local component +9.6%) and remains a high impact (LQ 1.6) and high wage (\$1,823 weekly) industry for the county.

Administrative and Waste Services

Locally, Administrative and Waste Services outpaced national industrial employment averages (local component +13.6%). The impact of this sector is increasing as the LQ remains above 1.0, however, the wages (\$808) are below county averages.

Educational Services

Employment growth in Educational Services outpaced national industrial averages (local component +8.5%), while wages grew more slowly (-1.1%) as compared to wage changes around the nation.

Health Care and Social Assistance


While employment growth in Nursing and Residential Care Facilities outpaced national industrial averages (local component of +1.9%) it fell overall (-326 jobs). We also had relative growth in Ambulatory Health Care Services, and Hospitals (local components of +12.9%, and 10.7%, respectively). The gains from Ambulatory Health Care Services outweigh the losses elsewhere as these jobs carry a higher wage (\$1,295) and similar or better LQ to the other health services subsectors. Wage growth in the Ambulatory Health Care Services, however, is lagging national growth (-8.4% local component) as compared to national industrial averages.

Arts, Entertainment, and Recreation

Overall, the industry lost jobs overall (-6.5%, for 276 jobs lost) and underperformed as compared to national industrial averages (local component of -7.5%). This was driven mainly by job losses in the Performing Arts, Spectator Sports, and Related Industries subsector (-173 jobs) and while Amusements, Gambling and Recreation (-189 jobs). The impact of the job losses in the Amusements, Gambling and Recreation subsector is less impactful due to the lower wages (\$640 weekly), however the losses in Performing Arts, Spectator Sports, and Related Industries subsector is meaningful as the wages are higher than average (\$1,426 weekly).

Accommodation and Food Services

Accommodation and Food Services were in recovery mode, gaining 2,548 jobs overall and outperforming the national recovery (local component of +13.6%, overall gain of 12.5%). Overall wage growth in the subsector was positive and outpaced national wage growth (local component of +6.7%). The county remains underserved by Accommodations (LQ of 0.8) but is continuing to make gains (LQ also improved from .6 to .7 from 2021 to 2022).



Other Services, Except Public Administration

Employment in Other Services, Except Public Administration outpaced national industrial averages (local component of +9.0%), with meaningful gains coming from all subsectors except the Private Household subsector (-125 job losses overall). The gains in the Repair and Maintenance subsector (279 jobs) are also impactful with an LQ of 1.3 and wages above the county average (\$1,084 weekly).
